We inform you that the above mentioned scientific session meets the requirements of

1. After the conclusion of the scientific session and within a period of 4 months, the following should be submitted to the National Drug Organization, with reference to the protocol number of the approval decision: the final program, the financial report, a list of the sponsor's names and the amount of sponsorship, as well as the number of the participants as resulted from the registrations which have been made, as well as a solemn declaration according to the law in force, in which it will be mentioned that the items of income and expenses are true.
2. The medical information should be in compliance with the current provisions.
3. The participant speakers in the scientific events, instead of a written statement, are requested at the beginning of their speech (in the 2<sup>nd</sup> slide after the title of their lecture) to refer to any conflict of interest.
4. The organization of the scientific event was assigned to the company " ERASMOΣ A.E."(P.C.O), which meets the requirements contained in the above circular ( ref: 64740/1.9.2013) of the N.O.M.

If the session is not funded by Greek pharmaceutical companies, the submission of  
accounting data is not required.
